

ADVANCING ENVIRONMENTAL SUSTAINABILITY GOALS THROUGH PUBLIC PROCUREMENT AND INTERNATIONAL TRADE POLICIES

In advance of the COP 28 Climate Change Conference, the International Trade Centre (ITC), in collaboration with the World Trade Organization (WTO), is showcasing the role of green public procurement (GPP) as a tool for advancing environmental sustainability goals and creating a growth-conducive business environment for developing country micro, small and medium-sized enterprises (MSMEs). Empowering public authorities to employ their purchasing power to procure goods, services and works more sustainably, while supporting MSMEs to participate in and benefit from the procurement process, will facilitate a successful transition to a green and inclusive economy, to the benefit of all citizens. International trade policies and initiatives can serve as an important enabling factor in this process.

Governments are increasingly using their purchasing power as a tool to achieve development objectives and build inclusive, resilient, and sustainable economies. The strategic use of public procurement as a tool for promoting environmental sustainability and mitigating the threats posed by climate change is referred to as green public procurement (GPP). A core objective is to align both public sector buyers and private sector suppliers with environmental goals and values, creating a growth-conducive business environment.

GPP can incentivize innovation and improve access to clean, green technologies and products. In fact, much public procurement pertains directly to actions necessary for the world to respond to and mitigate climate change and related ecological disasters, for example a successful transition to greener forms of energy, the construction of climate resilient infrastructure, waste systems, etc. Life-cycle costing (LCC), which integrates circular economy considerations into the evaluation of a contract, can provide important savings for public authorities.

Shifting the focus of public procurement from the lowest cost of acquisition to the promotion of sustainability and related values requires a **rethinking of the value proposition** and important adjustments to traditional procurement procedures. In fact, meeting the challenges and seizing the opportunities that arise from GPP will require both the **adoption of new domestic policy frameworks by governments** and **adaptation to the new frameworks by the private sector**. This can be particularly burdensome for MSMEs, especially in developing countries. A whole-of-government approach is needed to **promote green procurement in ways that take due account of the interests of developing country MSMEs**.

International trade policies and instruments can contribute both to reshaping national frameworks to support sustainability objectives and to the creation of related opportunities for MSMEs. Increasingly, regional and bilateral trade agreements such as the Korea-Australia FTA, and EU-Canada Comprehensive Economic and Trade Agreement (CETA) incorporate provisions to support the use of environmental criteria and objectives. The WTO Agreement on Government Procurement (GPA 2012) also plays an important role in **shaping public procurement rules** and is flexible enough to enable scope for consideration of environmental values and to facilitate participation by MSMEs.

This webinar aims to:

- Take stock of developments on GPP at the multilateral, regional and domestic level, also considering the role of specific international trade instruments, such as the WTO's GPA 2012.
- Highlight the need for domestic policies to be reviewed and reformed in order to better integrate environmental values over the life cycle of a procurement contract, also highlighting constraints faced by developing countries and MSMEs in leveraging GPP.
- Consider possibilities for addressing green procurement in trade policy negotiations and international trade agreements while encouraging MSMEs participation in procurement to strengthen green value chains.
- Assess key priorities for developing countries and MSMEs regarding this topic and consider how to better bring related perspectives into future negotiations and dialogues on GPP.
- Present the draft toolkit on Green Public Procurement and International Trade Policies for discussion.
