# **Boosting Trade Facilitation in Nepal**

Trade Facilitation and Policy for Business (TFPB)





## Background

High costs of moving goods across border significantly hinder the competitiveness of small and medium-sized enterprises (SMEs) in Nepal to successfully connect to international markets and global value chains (GVCs). Redundant documentary requirements, inefficient customs procedures and lack of transparency on trade information make it hard for SMEs to comply with cross-border procedures connected to export and import operations, but also considerably reduce investment opportunities for governments and businesses alike.

Many of the procedural obstacles faced by Nepalese businesses can be addressed by the full implementation of WTO Trade Facilitation Agreement (TFA), a landmark multilateral agreement that aims to cut red tape at the borders by simplifying, modernizing and making more efficient and transparent export and import procedures. Nepal has ratified the TFA on 24 January 2017 but has notified 26 measures in Category C, thereby linking its capacity to implement these commitments to the reception of financial and capacity-building support.

The trade facilitation component (Output 2) will support Nepal in the implementation of the WTO TFA and in the development of action plans for implementing selected Category C measures. In doing so, this component will strengthen the institutional and technical capacity of the Nepal's National Trade Facilitation Committee (NTFC) to drive trade facilitation reforms in the country. Complementarily, this component will also enhance private sector capacity to participate in trade-related public-private dialogues (PPDs) and advocate for trade facilitation reforms. Furthermore, this component will improve compliance level of coffee and pashmina businesses, especially SMEs, with export procedures by developing step-by-step trade facilitation guides.

## Results

The following results can be expected after completion of the activities:

- Strengthened capacity of the NTFC to coordinate and facilitate the implementation of the WTO TFA;
- Enhanced capacity of trade facilitation stakeholders to implement specific Category C commitments of the WTO TFA;
- Increased public and private sectors' awareness of the WTO TFA and enhanced capacity to implement and advocate for trade facilitation reforms in Nepal;
- Improved capacity of coffee and pashmina businesses, especially SMEs, to comply with export procedures.

- Technical trainings, workshops and coaching services for the NTFC, border agencies, private sector trade support institutions (TSIs) and businesses to implement and advocate for the implementation of trade facilitation reforms in Nepal;
- Step-by-step trade procedures methodology and solutions to increase businesses' compliance with export procedures in Nepal, with a focus on the coffee and pashmina sectors.
