#### **INTRODUCTION**

1. In conformity with the <a href="ITC Evaluation Policy">ITC Evaluation Policy</a>, <sup>1</sup> the Independent Evaluation Unit (IEU) prepares each year an annual Evaluation Work Programme, including a budget and a prospective plan for the subsequent year. The draft Evaluation Work Programme is submitted to ITC's Senior Management Committee (SMC) to discuss feedback on priorities, options, and endorsement.

## **DELIVERABLES**

### **Undertaken in 2022**

#### **Independent evaluations**

- 2. In 2022, the IEU has initiated or finalized the following independent evaluations:<sup>2</sup>
  - Midterm Evaluation of Improving the international competitiveness of the textile and clothing sector (MENATEX) in the MENA region The Programme team is currently finalizing the management response and it is expected that the evaluation will be presented to SMC Q2 2023.
  - <u>Evaluation of the ITC SheTrades Initiative</u> This evaluation was finalized in Q4 2022 and presented to the CCITF together with the gender moonshot. It will be presented to the SMC together with management response in Q1 2023.
  - <u>Final Evaluation of the Netherlands Trust Fund (NTF) Phase IV</u> This evaluation was finalized in 2022 and presented to the Programme's Steering Committee and to the SMC in Q2 2023.
  - The final evaluation of the project Colombia PUEDE: Peace and unity through productive development and commercialization The evaluation was initiated in 2022 and the final report will be presented to SMC on Q2 2023.

### 2022 Annual Evaluation Synthesis Report

3. The <u>2022 AESR</u>, included a new perspective, assessing the findings from the 2021/22 evaluation reports and related reviews against the main dimensions of the Strategic Plan 2022-25. This will help building knowledge for the implementation of the Strategic Plan 2022-25. The document was presented to ITC Member States and discussed at the annual ITC Joint Advisory Group meeting in September 2022.

#### **Developmental Evaluation Review**

4. The IEU completed in 2022 a developmental evaluation to support, and for real-time learning from, three large projects<sup>3</sup> M&E systems at their inception phase:

- Piloting Enhanced M&E Practices for Results Based Management at ITC: A Process
  Synthesis Report To ensure that learnings could be shared and replicated, through
  appropriate documentation, these learnings enabled an in-depth review for how
  decisions were made, and adaptations executed.
- Proposal for Large ITC Projects to Establish Good M&E Practices before Closure of Inception Phase More broadly, these learnings also informed the development of the corporate system DER proposal a companion output of the DER initiative to institutionalize good M&E practices for large ITC projects. The main goal from a corporate level perspective has been to develop and present a toolkit for large ITC projects to facilitate the adoption of a common set of M&E good practices, and to establish requirements to be achieved, by the end of inception phase. In doing so, it also provides a dynamic characterization of some M&E practices, systems, and challenges across the ITC portfolio. Its final goal intended for the benefit of project managers, supervisors, and M&E staff is to propose and describe a set of key steps by which the adoption of these good practices may be achieved. This proposal was presented and discussed with the SPPG team and will be presented to the SMC in Q2 2023.

#### **Sustainability Reviews**

- 5. The main aim of sustainability reviews is to assess the sustainability of projects results, three to four years after they have ended. In 2022, the choice was to concentrate on one ITC function and deep dive into analyzing the determinants that make ITC interventions in this area sustainable or not. Following a demand-driven approach, the IEU initiated the following analyses on the sustainability of the export strategy function, which is finalizing in Q1 2023:
  - Saint Lucia National Trade Strategy 2020-2024: Developed as part of the ITC project 'St. Lucia: Strengthening the institutional infrastructure for export promotion' (A332)
  - Burkina Faso Shea sector development strategy 2015-2019: Developed as part of the ITC/EIF project 'Elaboration of a sectoral strategy for the export and development of the shea nut sector in Burkina Faso'
  - Sri Lanka National Export Strategy 2018-2022: Developed as part of the ITC project 'Sri Lanka: Trade related assistance' (A306)

# Review of Knowledge Management in the ITC Evaluation Function

6. This Review focused on how learnings from IEU evaluation products could be best disseminated and "put to work" in light of user needs, resources, experience of other organizations. It concluded that the IEU had been seeking to optimize its knowledge management in a continuous and pragmatic fashion, suiting the size of the organization and that this approach seemed conscious of resources of the ITC generally and the IEU specifically. Findings also indicated that the IEU has a wide range of evaluation products, mirroring or even going beyond those offered by evaluation units in other bi- and multilateral agencies. It was suggested to continued focusing on accessibility, dissemination, and use of evaluation findings, in particular through the Steering Mechanism (see below).

### 2021 Project Completion Report Synthesis Review

7. Finally, in 2022, IEU completed the synthesis review of PCRs submitted in 2021. Among the main lessons learned conveyed by project teams through the PCRs, a common theme related to planning and coordination was the need to incorporate flexibility into project implementation. Many projects learned that they had to adapt their activities and mode of delivery to achieve their targets. In terms of project design, many PCRs emphasized the need to thoroughly identify and engage with project beneficiaries. Good coordination with donors and other development partners was also essential to reduce overlap of interventions. Aspects mentioned as contributing to project sustainability included replicating the project approach or taking advantage of expansion opportunities; access to finance; and ensuring value for money. Concerning quality aspects, the overall quality of the PCRs continued to improve in 2021. It was decided in consultation with the SMC, to stop the yearly production of this type of Review.

#### Planned for 2023

#### **Independent Evaluations**

- 8. Evaluation of ITC's Work on Agricultural Value Chain "Sustainable and resilient value chains" is one of the two Impact Areas as defined in the ITC Strategic Plan, which was still outstanding in terms of independent evaluation coverage. The option selected has been to focus the evaluation on ITC's work on agricultural value chains, to provide a comprehensive overview of the ITC portfolio in this area and to assess the quality and effectiveness of related activities. Considering the complexity and large scope of this evaluation (representing about half of the total ITC project portfolio<sup>5</sup>), the IEU undertook preparatory work in 2022, consisting in an inception phase with a portfolio and literature review. This work was presented and discussed with the MAG to obtain their feedback and priorities for the actual evaluation in 2023, consisting in data collection, analysis and report writing with a more in-depth assessment of specific activities. In alignment with the above-mentioned evaluation inception report, this evaluation will conduct a series of sampled case study projects<sup>6</sup> and two country case studies (Ghana and Pakistan).
- 9. In terms of W2 projects / programmes with a budget over USD 2 million, the IEU will conduct the following evaluations in 2023:
  - Final evaluation of the United Kingdom Trade Partnership (UKTP) Programme.<sup>7</sup>
  - Midterm evaluation of the NTF V programme.
  - Midterm Evaluation of Linking Ukrainian SMEs in the Fruits and Vegetables Sector to Global and Domestic Markets and Value Chains PHASE II.
  - The final evaluation of the project Systematic Mechanism for Safer Trade (SYMST)

(It is worth noting that for the latter three evaluations, project managers requested IEU to carry out these evaluations which are funded by the CBI of the Netherlands, Sida, and by the EU, respectively.)

10. Evaluation of the Ethical Fashion Initiative – In 2023, the IEU will conduct an independent evaluation of the Ethical Fashion Initiative. This is justified by the maturity reached by this programme since its early evaluation in 2013.<sup>8</sup>

#### 2023 Annual Evaluation Synthesis Report

11. EIU will continue with last year evaluation analytical framework to cover ITC's performance in achieving the 2022-2025 Strategic Plan corporate objectives. Within this framework, it will synthesize the critical learning and accountability points emerging from the independent evaluations, self-evaluations (including PCRs) and funder-led evaluations carried out during the previous year. The AESR will also report on the implementation of the recommendations of independent evaluations and of the previous AESRs.

### 2022-2025 Strategic Plan Midterm Review

12. As per the AESR 2021 management response commitments, the IEU will initiate the evaluation process of the 2022-2025 Strategic Plan, with the drafting of the terms of reference of the midterm evaluation, the constitution of the panel of experts (including selection criteria, terms of reference and members identification/selection) and the selection of the evaluation consultant / team. These elements should enable the actual launch of the midterm evaluation in Q1 2024.

#### Steering Mechanism on the Lessons Learned from the Implementation of the Strategic Plan

13. In 2023, as per ITC commitments of the AESR 2021 management response, a new steering mechanism will be established to contribute to consolidating corporate ownership over the lessons learned from the implementation of ITC Strategic Plans. This steering mechanism will act as a consultative body, at the ITC mid-management level, to support the SMC in its decision-making in matters related to the implementation of the Strategic plan, through the incorporation of collective bottom-up feedback from across the organization. It is also envisaged the steering mechanism acting as a "Sounding board" to reflect on the lessons learned from IEU's evaluation products and their dissemination, with a view to improve their value to the organization as well as an internal "Evaluation network" to enhance linkages between the IEU with all sections of ITC. The IEU has drafted its terms of reference in close consultation with the DED and Chief SPPG and will be presented to SMC in Q1 2023.

#### Good practices in the field event

14. Based on the lessons learned gathered through evaluation work, it is proposed to organize a meeting in Geneva with ITC colleagues in the field, to discuss and share with HQ colleagues their experience and good practices in supporting MSMEs' business development and income generation. The event will analyze successful intervention models for MSMEs support, improvements in M&E practices, and how HQ could improve its support to these initiatives. The

IEU will prepare a ToR for this event, including possible follow up actions, and will present it to SMC for its endorsement.

#### **ITC Evaluation Policy and Guidelines**

15. In 2023, the IEU will conduct a comprehensive update of its Evaluation Policy and Guidelines including the fulfilment of UN requirements in relation to the domains of Gender, Disability and Human Rights, with the perspective to submit these drafts to senior management for their endorsement in 2024.

# Foreseen in 2024 and beyond

# **IEU** managed work

- 16. As mentioned above, Midterm evaluation of the Strategic Plan 2022-2025 will be initiated in 2024.
- 17. In addition, another corporate independent evaluation to be initiated in 2024 could focus on the *Regional Integration and South-South Trade* impact area since this is the last impact area still outstanding in terms of independent evaluation coverage.
- 18. Independent Review of ITC W1 system Window 1 (W1) consists of un-earmarked and soft-earmarked contributions from funders. ITC invests these funds in initiatives which are critical to ensure that ITC remains at the cutting edge of Aid for Trade; maintains and develops global public goods that support enterprises in international trade; can respond flexibly to client needs; and performs efficiently in pursuit of 'good trade'. Building on the recent analysis undertaken by the SPPG<sup>9</sup>, the IEU will evaluate the relevance, coherence, effectiveness, efficiency, impact, and sustainability of the ITC W1 system.

### Possible project / programme evaluations

19. As set out in the ITC Evaluation Policy, projects / programmes with a budget of USD \$2 million or more are subject to evaluation. In this regard, projects / programmes with a budget over USD \$2 million and foreseen to finalize in 2023 / 2024 (as of the time of writing this work programme), a series of projects that could be subject to evaluation in 2024 or 2025 is listed in Annex 4.

#### **ADVISORY SUPPORT**

## **Evaluation capacity**

20. In 2023, all project managers whose project will be subject, either to an independent evaluation, or a self-evaluation (including PCRs), or a funder-led evaluation, will be invited to take the "Evaluation at ITC" course through the L&D Hub, which is not mandatory. The objective is to enhance ITC's staff evaluation capacity and to provide them with timely and comprehensive guidance complementing the unit's advisory services to conduct these evaluations.

### **Self-evaluations**

- 21. In 2022 the following self-evaluations were initiated or carried out:
  - Mid-Term Self-Evaluation of the project "ARISE Plus Malaysia"
  - Midterm Review of the "ARISE Plus Myanmar" project
  - Evaluation of Gender Mainstreaming in ITC evaluation It is expected that this evaluation will be finalized in Q1 2023.

In these cases, the self-evaluation was performed with the use of an independent evaluation consultant, whose selection was supported by the IEU. The IEU also provided advice on the drafting of the ToR, and ensure they conformed to the ITC Evaluation Guidelines and Policy. The Unit also reviewed the draft Inception and Evaluation Reports and provided feedback and suggested revisions. For the first two evaluations, the IEU also provided guidance on the management response process to ensure that the action plans to implement recommendations were well structured.

- 22. In 2023, the following tentative self-evaluation of a project with a budget over USD 2 m, might be conducted, (IEU has not yet received confirmation):
  - Refugee Employment and Skills Initiative: Building Solutions for Somali Refugees in a Fragile Protracted Displacement Scenario (RESI Dadaab II), (Jacub Michalak, DSIT/WYVC)

#### **Funder-led evaluations**

- 23. In 2022, the IEU provided support to several project managers whose projects were subject to funder-led evaluations (e.g. an evaluation commissioned and managed by the funder). The IEU provided advice on processes and procedures, and in some cases helped to review the TOR, reviewed the draft report and provided feedback, and gave advice on drafting the management response where applicable.
  - EU-EAC Market Access Upgrade Programme MARKUP midterm evaluation
  - Lao PDR: ASEAN Regional Integration Support (Laos-ARISE Plus) midterm evaluation
  - Nepal Trade-Related Assistance midterm evaluation
- 24. In 2023, the following funder-led evaluations have been confirmed:
  - State of Palestine: Reform and Development of Markets, Value Chains and Producers'
     Organizations final evaluation will be conducted by FAO of the overall programme,
     including the ITC component (BESEISO, Eman, DCP/OMENA)
  - Bhutan Trade Support final evaluation will be conducted by the EU, (COCHIN, Sylvie, DCP/OAP)
  - Thailand: Trade-Related Assistance (Arise + Thailand) final evaluation will be conducted by the EU (COLONNA, Ingrid DCP/OAP)
  - T4SD database midterm evaluation undertaken and funded by SECO /BMZ.

- 25. In addition, the following funder-led evaluations could be conducted in 2023 (the IEU has not yet received confirmation):

# **Results Oriented Monitoring Reviews**

- 26. The IEU provided support to several EU-funded projects that were subject to a Results Oriented Monitoring (ROM) Reviews. In these cases, the IEU provided information sessions tailored to the ROM process, indicating what was expected from the project team, and what to expect at each stage of the ROM Review process. These information sessions helped to prepare the project manager and teams and provided an opportunity for IEU to share lessons learned from other projects that had experienced a ROM review. The IEU also provided feedback on draft ROM review documents including their recommendations:
  - ECOWAS: West Africa Competitiveness Programme (WACOMP)
  - Uzbekistan: Facilitating the Process of Accession to the WTO
  - Thailand: Trade-Related Assistance (Arise + Thailand)
  - Pakistan: Growth for rural advancement and sustainable progress (GRASP)
  - Caribbean: Development of value-added products and intra-regional trade to enhance livelihoods from coconuts II
  - Colombia PUEDE: Peace and unity through productive development and commercialization
  - République Centrafricaine: Programme d'appui à la promotion de l'entreprenariat en milieu urbain et rural (PAPEUR)
  - Iraq: Strengthening the Agriculture and Agri-Food Value Chain and Improving Trade Policy (SAAVI)
  - Iran: Trade-Related Technical Assistance, Capacity Building, and Value Chain Development for Inclusive and Sustainable Trade-Led Growth
- 27. According to information made available to the IEU, the following ROM Reviews should be concluded in 2023:

# **Project Completion Reports**

- 28. IEU continued offering its support to project teams, through training, and upon their request and as part of its advisory services, in their dialogues to discuss PCR preparation to pave the way for a common understanding of project performance and improvements to be introduced in future interventions. In terms of follow up, the IEU undertook the following actions:
  - In 2022 the digital development of online PCRs submission and approval had a significant
    impact on PCR performance and compliance, as project managers can now complete,
    submit, and approve the PCRs online directly without delay, and as the PCR report itself
    can be extracted from the project portal through a link accessible to all stakeholders for
    review and sharing knowledge.
  - In terms of tracking and follow-up of PCRs before the due date; the IEU established a PCR
    monitoring file, where we regularly track and follow-up with project managers for due
    time PCR submission. This monitoring file is updated on a weekly basis and shared with
    the SMC on a quarterly basis.
  - In addition, the IEU conducted a detailed PCR training to benefit the project teams from the new technical developments and ensure the quality and compliance of PCRs.
- 29. In 2022, 100% of projects complied with the submission of their PCRs within the mandated 6-months period after project completion. 51 Project completion reports were completed, submitted, and approved by Chiefs and Directors.
- 30. In 2023, the IEU will continue supporting project teams with this endeavor. 11

### **EXTERNAL ENGAGEMENT**

### UNEG

31. In 2022, the IEU actively participated in the work of the UN Evaluation Group (UNEG) and contributed to the work of UNEG working groups related to "Gender, Disability and Human Rights (GD&HR)" and "Ethics and Code of Conduct". The IEU attended GD&HR working group meetings, provided feedback on the UN-SWAP Evaluation Performance Indicator 2021 Reporting Cycle Results, and reviewed the revised Guidance on integrating disability inclusion in evaluations and reporting on the UNDIS accountability framework evaluation indicator. The engagement in the GD&HR working group will continue throughout 2023.

#### **UN SWAP**

32. The Unit contributes to corporate reporting on ITC's involvement with the UN System-wide Action Plan (UN-SWAP) on Gender Equality and the Empowerment of Women (GEEW). In Q4 2022 and Q1 2023 the IEU continued to support the implementation of the UN-SWAP by reporting on KPI 4

- Evaluation, by conducting a meta-evaluation, and completing the UN-SWAP Evaluation Scorecard to analyze the evaluations completed during the year.

#### **UN DIS**

33. The Unit also contributes to ITC's corporate reporting on the implementation of the UN Disability Inclusion Strategy (DIS) through KPI 10 – Evaluation. According to the 2022 reporting, to rate as approaching requirements, the ITC evaluation guidelines must contain guidance on how to address disability inclusion in evaluation, as outlined in the <a href="UNDIS Technical Note">UNDIS Technical Note</a>. This will be accounted for when the ITC evaluation guidelines are updated in 2023. The Unit will continue to support the implementation of the UNDIS in coordination with the ITC Disability and Accessibility Focal Point.

#### OIOS

- 34. In 2022, the IEU took part in three Office of Internal Oversight Services (OIOS) evaluations, which will be completed in 2023:
  - The Evaluation Study of the UN Evaluation Dashboard 2020-2021 (an internal document); and
  - The assessment of Strengthening the role of evaluation and the application of evaluation findings on programme design, delivery and policy directives (a formal document to be submitted to the General Assembly in March 2023).
  - The Thematic evaluation of United Nations Secretariat support to the Sustainable Development Goals.

# JIU

- 35. As the focal point for Joint Inspection Unit (JIU), in 2022, the IEU contributed to the completion of JIU reports, including:
  - Review of business continuity policies and practices in UN system (JIU/REP/2021/6).
- 36. The IEU facilitated ITC's participation in several JIU reviews that are still ongoing, including:
  - Review of policies, measures, mechanisms, and practices to prevent and address racism and racial discrimination in the UN system (A.457 – Review focal point DPS/HR);
  - Review of the internal pre-tribunal stage appeal mechanisms available to staff members in the UN system (A.460 – Review focal point DPS/HR);
  - Review of accountability frameworks in the UN system (A.462 Review focal point OED/SPPG/IEU);
  - Flexible working arrangements in UN system organizations (A.463 Review focal point DPS/HR);
  - Review of mental health and well-being policies and practices in UN system organizations
     (A.464 Review focal point DPS/HR);
  - Review of the acceptance and implementation of JIU recommendations by the UN system organizations (A.466 Review focal point OED/SPPG/IEU);

- Review of the quality, effectiveness, efficiency and sustainability of health insurance schemes in the UN system (A.467 Review focal point OED/SPPG/IEU and DPS/HR); and
- Review of the use of non-staff personnel and related contractual modalities in the UN system (A.468 – Review focal point DPS/HR).
- 37. In 2022, the IEU reported on the implementation of JIU recommendations to ITC, which was made possible through the reporting provided by many staff. However, even though ITC did not actively participate in all JIU Reviews, it was still subject to receiving JIU recommendations regardless of its involvement. This has led to a scenario where subject-matter focal points are required to provide reporting on the implementation of recommendations, even if ITC has not actively participated in the Reviews. In 2023, the IEU will continue to play its role and following-up on past JIU recommendations issued to ITC.

#### **BUDGET**

- 38. ITC management supports the JIU recommendation of developing a comprehensive budget framework and resource allocation plan for the ITC evaluation function. In addition, to staff resources, the IEU receives an annual RB allocation of USD 216,000.<sup>12</sup>
- 39. The indicative budget below covers costs necessary to produce evaluation deliverables:
