And in this first post-COVID conference, over 600 businesses, governments, NGOs, women and youth from 70 countries came to Ulaanbaatar to talk trade, do business and drive development.

The B2B sessions of the forum generated 4.5 million U.S dollars in potential trade and investment leads.

The issue of landlocked developing countries was high in the forum's agenda, with the participation of High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States as well as with the participation of the International Think Tank for Landlocked developing countries in the forum, Mongolia moved the discussions forward to feed in the LLDC Conference in Rwanda next year.

During the forum, Mongolia's SheTrades Hub with National Chamber of Commerce and Industry was launched and a workshop to design Mongolia's National Export Strategy was held to identify the priorities for a 5-year export diversification action plan with and for the public and private sectors.

Using this opportunity, I would like to express Mongolia's heartfelt appreciation to the donor community for enabling the ITC to deliver its technical assistances, capacity building and innovative analysis which fits to the specific developmental needs of each partnering country.

I particularly would like to thank Madame Executive-Director Pamela Coke-Hamilton, as well as Madame Deputy Executive Director Dorothy Tembo and the entire team of ITC for their hard work and dedication in developing trade, empowering women, and youth in the developing world, especially, in this time where MSMEs around the globe are most challenged.
